On Spiritual Discernment

Romans 13 & 14

The word “discern,” as defined by Merriam-Webster online, is to grasp, comprehend, or perceive. Biblically the word “discern” or “discernment” is used to communicate many different meanings and has some slight differences. Some of the meanings include: distinguish, separate, examine, scrutinize, question, perceive, understand, determine, decide, judge, know, test, and prove. In general, to discern means to decide, or judge, between right and wrong, good and evil.

Throughout the Old and New Testaments we are instructed by various writers, prophets, and apostles to discern. So how do we go about discerning? Well, it seems pretty simple. Just “decide between right and wrong” then do the right thing. However, it’s not always that obvious. “Black and white” situations are not difficult to discern (i.e. murder, adultery, stealing). I most often need discernment when the situation is gray. Sometimes finding clarity, even in scripture, is difficult. Paul, for example, tells the believers in Rome to “Let every person be subject to the governing authorities.” Then Paul immediately follows his apostolic command with a reason: “For there is no authority except from God...”, and adds “...whoever resists the authorities resists what God has appointed, and those who resist will incur judgement” (Rom. 13:1-2, ESV).

Ok. Got it. Simple. Incurring judgement doesn’t sound all that great so we decide to submit ourselves to the governing authorities. This discernment thing doesn’t really seem all that difficult. Paul says to submit to civil authorities, so we should submit. No. Unfortunately, it’s not always that black and white. There’s more to it than just following a command. Sometimes we need to examine the situation. We need to look at the context of the issue at hand. In this case, “*If the governing authorities command us to do something God forbids, or forbids us to do something God commands, we must disobey those in authority*” (R.S. Bible, p. 2004, theological note “Civil Government”).

So, what Paul tells us in Romans is not a command that we need to follow? Or is Paul telling the Roman Christians (and us) that his Apostolic command is conditional? If it is, then how do I know when to submit to civil authority and when to disobey civil authority? And how do I know which of God’s commands are conditional? Are God’s commands conditional?

Even the Apostle Paul didn’t really have definitive black and white answers (that removed all doubt) for the Roman Christians when it came to eating meat and vegetables, or for those who wanted to celebrate special days and those who didn’t, and what to do about these types of situations. He did

write about it. Paul wrote a whole chapter (Romans 14) on how to think and act in difficult, unclear, or confusing situations.

The difficulty in situations like the one Paul speaks to in Romans is not about unclear instructions but about how Christians perceive situations and perceive God’s expectations. Paul isn’t giving us a simple “if A then B” answer. What Paul is showing us is how to think. He is showing us how a spiritually mature believer should process information. Paul gives us guidelines and principles to apply in any situation. Our perception of the lives of other believers should be soaked in the “*righteousness, peace, and joy of the Holy Spirit*” (Rom. 14:17) and tempered with “*what makes for peace and mutual edification.*” (Rom. 14:19). Paul paints a picture that illustrates what Christian maturity and spiritual growth look like. He shows us where to begin when we find ourselves in need of a little discernment.

Paul asks “*Who are you to pass judgement on the servant of another? It is before his own master he stands or falls*” (Rom. 14:4). He then informs his readers that a believer “*should be fully convinced in his own mind*” (Rom. 14:5) because if a Christian’s actions are to honor the Lord and give thanks to God, then whether he lives or dies he is the Lord’s (Rom. 14:7, 8). Paul then brings us to the judgement seat and says “*each of us will give an account of himself to God.*” (Rom. 14:12). Simply put, Paul has given the Roman Christians (and us) a place to begin, a discernment filter, an example of how we need to scrutinize, test, examine, judge, perceive, decide, etc.

Let’s go a little deeper. Although we’ve only scratched the surface of how to discern, let’s take a look at why discernment is important and how we can get better at it. I think the Apostle Peter clearly answers the why and how when he writes “*...he has granted to us his precious and very great promises, so that through them you may become partakers of the divine nature...For this very reason, make every effort to supplement your faith with virtue, and virtue with knowledge, and knowledge with self-control, and self-control with steadfastness, and steadfastness with godliness, and godliness with brotherly affection, and brotherly affection with love. For if these qualities are yours and are increasing, they keep you from being ineffective or unfruitful in the knowledge of our Lord Jesus Christ. ...be all the more diligent to confirm your calling and election, for if you practice these qualities you will never fall.*” There it is. “**...for if you practice these qualities you will never fall.**” How? Practice. Why? So you will never fall.

How to Test for Right and Wrong

The Bible is a book of principles, so it does not always tell us exactly what thing we may or may not do. Some matters must be determined by thoughtful application of Biblical principles. The following tests for right and wrong are suggested for those who are honestly trying to live righteous lives.

1. **DOUBT:** If there is doubt in one's mind regarding a thing, **it should be left undone.**
"He that doubteth is condemned if he eat, because he eateth not out of faith, and whatsoever is not of faith is sin." Romans 14:23.
2. **PUBLICITY:** If one would not want what he does to be made known in public, **it should be left undone.**
"For God shall bring every work into judgment, with every secret thing, whether it be good or whether it be evil." Ecclesiastes 12:14.
3. **ASSOCIATION:** If what one does is associated with what is known to be wrong, **it should be left undone.**
"Abstain from all appearance of evil." 1 Thessalonians 5:22
4. **INFLUENCE:** If what one does might create the wrong impression upon someone else, **it should be left undone.**
Therefore, if meat makes my brother to offend, I will eat no flesh while the world standeth, lest I make my brother to offend." 1 Corinthians 8:13
5. **EXPEDIENCY:** If a thing which may otherwise be alright is questionable at certain times and under certain circumstances, **it should be left undone** when not expedient.
"All things are lawful for me, but not all things are expedient." 1 Corinthians 10:23
6. **FORETHOUGHT:** If a thing may ultimately lead downward instead of upward, **it should be left undone.**
"Prove all things; hold fast that which is good." 1 Thessalonians 5:21

If these things are conscientiously applied, there should be few questions regarding any act or conduct. In most matters of a moral or recreational nature, earnestness, intellectual honesty, and common sense will solve the problem.

These principles are generally sound, if indeed one's goal is to live a clean and righteous life.
